**NOW THEREFORE, BE IT RESOLVED** by the Town Board of the Town of Binghamton that The Town Board hereby adopts the 2024 Broome County Multi-Jurisdictional Hazard Mitigation Plan. Any further updates to the Plan must be approved by the Town Board to be effective.

# Chapter 106 – Buildings, Dangerous or Unsafe

## 106-3 Notice to Repair

- A. The structure has no electricity nor running water, therefore, toilets cannot be flushed (sanitation).
- B. There is no source of heating (no electric).
- C. We believe the owner is occupying the inside of a junk camper with a generator being the source of power, creating a potential carbon monoxide poisoning situation.
- D. There is junk and garbage scattered all over the property, on the Town's road, and in the Town's right of way.
- E. There are junk vehicles, boats, and campers on the property.
- F. It is my humble opinion that the Town Board should set a date, time, and place for a hearing and have the said property owner appear before the Town Board to present a plan of action to resolve the issue of the unsafe and a dangerous structure. (106-3 Notice to Repair)
