

Reopens May 1st

Spring is now upon us, and I'm really looking forward to getting outdoors and enjoying the sunshine. We're starting to see some of the usual Town activities return, so I'd like to talk about some of them here.

Back by popular demand, our "Municipal Cleanup Days" will be held on Friday, April 25 and Saturday, April 26, 2025. We've listed all of the details on page 3 and you should have recently received a reminder postcard in the mail. Spring is always the perfect time to clean up the junk around the house, and I hope you'll take this opportunity to get rid of it for FREE!

I'm pleased to announce that the Town's Community Center is reopening for rental after some recent renovations. We anticipate renting it out beginning on May 1, 2025, with new pricing going into effect. Please see the bottom of page 8 for details.

The Town of Binghamton was recently awarded funding for a CDBG program (Community Development Block Grant). This grant will provide financial assistance to owner-occupied, income-eligible homes throughout the Town, for housing repairs such as roofing, insulation, siding, plumbing, heating, electric, masonry, windows, doors, and carpentry. THIS IS A GRANT and NOT A LOAN. Thoma Development Consultants of Cortland prepared the CDBG application. Residents interested in being placed on the waiting list should contact Thoma Development Consultants at 607-753-1433 to request a pre-application. We're hoping some of you will take advantage of this great opportunity!

Finally, the Town Board and I are interested in hearing some feedback from our residents. We'd like to know: Are there any areas in our Town that you would like to see some improvements made and if so, what exactly? For example, maybe you'd like to see a slide added to our playground at the park, etc. I'd love to hear your ideas. Did you ever think we would get through this winter? The flakes started on Thanksgiving, and it feels like they will never go away! I'm happy to say "Welcome Spring!" We at the Highway Dept. have a lot of things scheduled for the upcoming road season. We're ready to get out of the plow trucks and into the warm sunshine! We'll be starting with pothole repair, shoulder and ditch work, then paving.

A few notable notes. Brush and branch pickup began in early April and will end on Fri., May 2<sup>nd</sup>. There is no need to call in for a pickup. We'll be cruising the town several times a week looking for those piles. Please remember . . . once May 2<sup>nd</sup> arrives, our brush & branch pickup will end. More information on the branch pickup is mentioned below.

April is National Safe Digging Month. It doesn't matter what you are digging for, whether it's planting a new tree, extending a garden, installing a new fence or a deck, it is the law that you notify <a href="UDigNY.org">UDigNY.org</a> or call 811 two days in advance to put in your location request. A utility locator will come and mark the underground utilities. This helps keep our vital buried utilities from being damaged.

### TREE BRUSH & BRANCH PICKUP IS UNDERWAY. ENDS ON FRIDAY, MAY 2ND.



As mentioned above, we are currently picking up tree branches, and the service will end on Friday, May 2nd. No cuttings from any kind of bush. Due to the overwhelming response to this service, you will not be given a specific day or time when your tree branches will be picked up; simply place your pile at the curb or edge of the road. CALL ONLY IF YOU HAVE A LARGE PILE THAT NEEDS TO BE APPROVED. Our number is (607) 669-4323. There are certain guidelines to be followed:

- Tree branches from your yard only; no cuttings from any kind of bushes.
- Put branches neatly along the curb/roadside in front of your home.
- Please place the large end of the branch towards the road, and leave the branches as long as possible. No piles that look like pickup sticks.
- No brush from clearing your lot.
- No brush from contractors or landscapers. (This means if you hire someone to maintain your lawn, they need to dispose of the debris; we will not take it.)
- Large piles must be approved.

The following items WILL NOT BE ACCEPTED and will be left behind: tree trunks; roots of any sort; clippings from lawns, flower beds, or vegetable gardens; thorny brush and small twigs; leaves and animal waste.

The Water/Sewer Billing Schedule for 2025 is as follows: (these are approximate mailing dates)

November 1, 2024 (1st billing of a cycle); due in early December February 1, 2025 (2nd billing); due in early March May 1, 2025 (3rd billing); due in early June August 1, 2025 (4th billing); due in early September

### **ATTENTION: SENIORS TURNING 65 AND OLDER**

We want to remind all current participants in the Low-Income Senior Program and those who will be turning 65 in 2026 who may qualify for the Enhanced Star exemption next year to <u>PLEASE KEEP YOUR 2024 TAX RETURN IN A SAFE PLACE</u>. Keep it accessible because eligible residents will need to bring it with them for processing their new Low-Income Senior Exemption and new Enhanced STAR Exemption for 2026.

Also, keep an eye on the mail in the fall as your annual renewal form will be mailed out at that time. Again, you'll be required to bring in your 2024 <u>Income Tax Return for 2026</u>. Having the required tax return will help process your application quickly. Thank you and enjoy the spring!

NOTE: You do not need to renew Enhanced Star.

With spring upon us, there are a lot more people in our parks enjoying the weather. We've been seeing a lot of dogs running without a leash, and we're also noticing a lot of dog poop on our Town properties. The Town of Binghamton Dog Control Ordinance, Local Law Chapter 88, Section 88-5, states: "It shall be unlawful for any owner of any dog in the Town to permit or allow such dog to: (A) Run at large and (F) Create a nuisance by defecating, urinating, or digging on public property, or on private property, without the consent or approval of the owner of such property." Dogs are to be on leashes at all times during visits to our parks, and it's your

responsibility to clean up after your dog. We've noticed that some people are bringing plastic baggies and using them, but they're not disposing of them properly. Instead, we're finding the baggies filled and placed in the flower garden and various other places. There are garbage barrels throughout our parks for you to use. Please use them. With the number of people attending our park activities, the last thing anyone wants to do is step in your dog's poo.



We're assuming you've already read that the Town is holding "Municipal Cleanup Days" again. Some of you have received letters from our office about code violations pertaining to the open storage of junk on your property. This is the perfect opportunity to get rid of your junk for free. We highly encourage all of you to take advantage of this service and to clean up around your property.

Finally, if you accepted financial assistance for the rehab of your home provided under the Community Development Block Grant (CDBG) Program, the receipt of those funds includes a continuing obligation to maintain your property in a neat and clean condition in compliance with all New York State and Town Code requirements. If you have a CDBG grant and allow your property to decline, you'll receive a letter from our office, warning you of the default and a deadline to restore it.

## Broome County Landfill's Spring/Summer 2025 Electronics and Hazardous Waste Drop-Off Dates




The Broome County Landfill continues to accept hazardous waste (including household and auto batteries, propane tanks, fluorescent bulbs, driveway sealers, paints, solvents, stains, cleaners, pesticides, and pool and photography chemicals) AND old electronics (such as computers, printers, stereos, TVs, copiers, fax machines, mobile phones, etc.) You can drop these off at the landfill on the following days, FREE OF CHARGE from 7:30 a.m. until 11:30 a.m.:

Sat., May 3 / Weds., May 7 / Sat., May 17 / Weds., June 4 Sat., June 7 / Sat., June 21 / Weds., July 2 / Sat., July 12

#### News from Our County Legislator Kelly Wildoner

Kelly Wildoner is a County Legislator representing District 3 which includes the Towns of Binghamton & Conklin along with a part of Vestal.



As the warm weather approaches, I wanted to take a moment to update residents in the Town of Binghamton on what we've been working on in the County and the Town.

At the conclusion of our budget process in November, we approved a 9th County property tax cut in a row for the residents of Broome County. Not only did we cut taxes, but we were also able to maintain all the County's critical services that are used by the people in our area. We have continued to make strategic investments in our community, including investments in public safety, infrastructure, as well as parks. We are very proud to be able to provide these much-needed services to the people in Broome County!

There are a lot of great projects going on around the County that will benefit people in our community, including the work force, our Veterans, and families. On the Northside of

Binghamton, our Veterans Resource Center and tiny homes project has made great headway and should be completed in the coming months. This project will consolidate Veterans services into one location and provide housing for a number of homeless Veterans. This has been a great team effort from County, State, and Federal officials.

At the Oakdale Commons, we are working to support a new daycare program to help families in our area find childcare. The need for childcare is clear in Broome County and hopefully this will provide more options for hardworking families.

The Discovery Center is a great place for families to spend time together. It offers a great experience, no matter the weather! They just finished up construction of their Pirate Ship Playground in October. The County provided a Small Community Fund grant to help with the construction of the playground. If you haven't yet, please stop down and check it out. The weather is getting nicer, and it would be a great place to spend time on a spring day with your kids or grandkids!

Being a County Legislator is very fulfilling. You are able to see the work you do every single day and how it impacts our residents. Spring is here, and even our pets know it. They get spring fever, too, and that means they'll soon want to spend even more time outdoors and may get frisky and want to go on a run!



This is a friendly reminder that if I pick up your dog when it's running at large and find that is has no ID and is not licensed, I'll take it to the Broome County Humane Society. In order to retrieve your dog from the shelter, you'll not only have the fees of licensing your dog and getting a rabies vaccination for your dog (if it doesn't have one), you'll also be charged an additional \$50 seizure fee from the Town then another \$50 sheltering fee for sheltering your dog at the Humane Society. If your dog is picked up and taken to the shelter, it could be very costly to redeem it. Please license your dog to avoid the extra fees.

### **DOG LICENSE RENEWAL INFORMATION**



The Dog License "Notice of Renewal" is mailed two weeks prior to your license renewal date as a reminder that your renewal is coming due. Please take the opportunity to make sure that your rabies certificates are up to date and that you renew your dog license as soon as possible.

- If the renewal is not paid after 30 days of your due date, you will have a \$10.00 Late fee.
- If the renewal is not paid after 60 days of your due date, you will have a \$20.00 Late fee.
- If the renewal is not paid after 90 days of your due date, you will have a \$30.00 Late fee.

Please be NOTE: These fees are in addition to the standard licensing fee.
