WHEREAS, notice was given that the Town Board scheduled a public hearing for December 2, 2025 at 4:01 p.m. at Town Hall, 279 Park Avenue, Binghamton, New York for public input on proposed Local Law NO. 3-2025 entitled "A Local Law Affecting a Temporary Moratorium Within the Town of Binghamton on the Development and Construction of Solar Energy Systems.", and

WHEREAS, notice of said public hearing was duly advertised in the Official newspaper of the Town and posted on the Town Clerk's signboard; and
